Dear Mr. Putin:

I would like to start by introducing myself. My name is Constantin Burlacu and I am a nationalist, an anti-communist and a freedom fighter descending from Romania. I came to the United States with my family in 1980 as a political refugee, escaping the persecutions endured under the communist dictatorship regime during the times of the former Socialist Republic of Romania. After establishing myself in this new country, I continued fighting the tyranny of the communist regime still taking place in my native country. Thanks to the American patriot and hero, Ronald Reagan, for who I have great admiration and respect, the anti-human communist evil empire in the former Soviet Union, and other former communist countries collapsed. I sacrificed many years out of my life fighting the communist monster, but the wounds have not yet been vindicated. From exile, in 1985, together with other Romanian patriots, we revived the League of National Defense, an ultra-nationalist Romanian organization founded on March 4, 1923 in Iasi, Romania, to defend the Romanian national cause and fight against the Jewish-communist conspiracy. And you can only imagine how proud I am, with my contributions to destroying the communist evil empire in Romania and other former communist countries, and that today the people of my native country can breathe the free air of liberty and democracy.

I first heard of you in 1998 when, as a KGB veteran (you served in the KGB for 15 years, rising to the rank of Lieutenant Colonel), you were appointed by the first President of the Russian Federation, Boris Nikolayevich Yeltsin (1991-1999) to Director of the Federal Security Service of the Russian Federation (FSB). As far as I know, this secret service was named FSK,

but was later renamed and reorganized into the FSB by the Federal Law of April 3, 1995, and is the main domestic security service of the Russian Federation and the main successor agency of the Soviet-era Cheka, NKVD, and KGB. The FSB has its headquarters in Lubyanka Square in Moscow, the same location as the former headquarters of the KGB. "The Soviet Union had one KGB officer for every 428 citizens. Putin's Russia has one FSB-ist for every 297 citizens", said a former KGB agent and former Chief of the Secret Service (Securitate) of Romania who defected to the U.S.

In 1999 you succeeded Yeltsin as Federal President, and your first concerns were to increase FSB's powers to run the state, suppress Chechen and other separatists, and "impose the right to electronically monitor the population, control political groups, search homes and businesses, infiltrate the federal government, create its own front enterprises, investigate cases, and run its own prison system", as stated by the aforementioned former Chief of the Secret Police of Romania. Therefore the FSB is much more powerful than the KGB was.

In the year 2000 and again in 2004, you were elected President of the Russian Federation. This is one of the greatest realizations that you could achieve in your life, and I believe you were extremely delighted with this honor and grateful for this miraculous opportunity. Columbia Encyclopedia, Copyright © 2001-08 Columbia University Press, states that: "Putin

moved quickly to reassert the central government's authority over the various republics, regions, and other administrative units and has sought to exert control over elements of the independent media. He also has worked to revamp, and reduce the size of, the military. He won enactment of liberal economic reforms and ratification of international arms agreements, while also renewing ties with former Soviet client states and maintaining Russia's strong opposition to proposed U.S. ballistic missile defenses... Putin's second term has been marked also by increasing government control over Russian oil and gas, the use of economic retaliation against nations that clash politically with Russia, and the gradual contraction of press freedoms”.

You have all the right to oppose the installation of U.S. ballistic missile defenses in Europe, or NATO's expansion to your country's borders. The mistake was made by Mikhail Sergeevich Gorbachev, who was the last General Secretary of the Communist Party of the Soviet Union, serving from 1985 to 1991, and also the last Head of State of the USSR, serving from 1988 until its collapse in 1991, and by President Yeltsin, for not asking to disassemble NATO at the same time they were dismembering the Military Treaty of Warsaw. Now, Russia pays the consequences. Even though NATO was incapable of firing a single bullet against the Iron Curtain to free the European Nation which was subjugated by communism; NATO now acts like a big military power invading only certain countries with orders from the Jewish New World Order tyranny. It is ironical that in some way, the U.S. and NATO took the role of the Soviet Union and became the World's Police to defend Jewish interests. This is not a part of Ronald Reagan's legacy and this compromising course of action should be completely eliminated from American policy. Also, I don't agree that you strip the rights and liberty of the republics and regions of Asia, or their independence, and force them into being a component of the Russian Federation. This means that you have the same colonialist and totalitarian tendencies as your predecessors from the Kremlin. I wonder if these people with Mongol-Tatar eyes from these republics and regions occupied by Russia look like Russian-Slavs? Of course not! So then why do you force them to stay in the Russian Federation, to exploit them and take their oil, gas and other resources?!

According to constitutionally mandated term limits, you were ineligible to run for a third consecutive Presidential term. In the presidential election of March 2, 2008 your friend Dmitry Anatolyevich Medvedev became the third and current President of Russia, inaugurated on May 7, 2008. As a friend, and his boss, your successor nominated you on May 8, 2008 to be Russia's Prime Minister.

Dear Prime Minister Putin, the principal reason I am writing to you is regarding the article “Nationalism of Putin's Era Veils Sins of Stalin's” by Clifford J. Levy, published in the New York Times on November 26, 2008. The contents of this article disappointed and revolted me entirely. In his article, Mr. Levy specifies: “And so a historian named Boris P. Trenin made a plea to officials. Would they let him examine secret archives to confirm that there was a mass grave here from Stalin's purges? Would they help him tell the story of the thousands of innocent people who were said to have been carted from a prison to a ravine, shot in the head and tossed over? The answer was no, and Mr. Trenin understood what many historians in Russia have come to realize: Under Vladimir V. Putin, the attitude toward the past has changed. The archives that Mr. Trenin was seeking, stored on the fourth floor of a building in Tomsk, in boxes stamped “K.G.B. of the U.S.S.R.,” would remain sealed. The Kremlin in the Putin era has often sought to maintain as much sway over the portrayal of history as over the governing of the country. In seeking to restore Russia's standing, Mr. Putin and other officials have stoked a nationalism that glorifies Soviet triumphs while playing down or even whitewashing the system's horrors. As a result, across Russia, many archives detailing killings, persecution and other such acts committed by the Soviet authorities have become increasingly off limits. The role of the security services seems especially delicate, perhaps because Mr. Putin is a former K.G.B. officer who ran the agency's successor, the F.S.B., in the late 1990s.”

After reading the entire article, I concluded that you are neither a democrat nor an honest man, like you want us to believe. On the contrary, you are an anti-human monster as Lenin, Stalin and other Soviet Judeo-Bolsheviks were. I thought that during your presidency you would

distance yourself from retrograde Marxist-Leninist ideologies; bring to light the anti-human methods used by the Communist Evil Empire, and condemn the persecutions and crimes committed by the Soviet Union against innocent people, as your predecessors, Gorbachev and Yeltsin did, but this did not happen on your part. During the time when I was arrested and interrogated by the Secret Police (Securitate, sister of the KGB) in Romania, for Nationalist and anti-Judeo-communist political activities, I met officers of the communist secret police who hate the communist dictatorship regime as much as I do. I thought in the beginning that you were part of this special category of people, but I was wrong. Instead of rejecting the diabolic Judeo-communist methods of Cheka, N.K.V.D and the KGB and starting the communist trials to bring the truth to light, you banned access for 75 years to political files from the secret archives of the FSB, the newer name of the KGB. Why? Is this perhaps because you were advised by Israel, and the Zionist supremacy elite not give access or any information about the Soviet Secret Police files, because they don't want people to find out that the evil Jews, who arrogantly call themselves "God's chosen people", are behind the communist repressive apparatus, and that they ordered the persecution, arrest, deportation, imprisonment and execution of innocent people?! The Jews do this to escape trials and avoid being forced to pay for the crimes they committed against humanity during the communist era, as they forced Germany to pay compensation for the pretension of crimes committed during the Nazi era. Being desperate, they attempt to change the story by posing as victims of communism while blaming Russia and other nations for the red holocaust against non-Jewish people. Serving their own self-interest, Jews infiltrated in all political, social, economic, military, and religious organizations, while expecting others to take responsibility for their repugnant influence and illegal actions.

According to the Israeli historian Brayan Mark Rigg, in his book "Hitler's Jewish Soldiers", he points out that many Jews held high positions in the Nazi Military and Party, but Jews don't blame those Jewish-Nazis for what happened to them during the Nazi "holocaust". They don't want to talk about this, and only accuse German descendents for being responsible for the Nazi "holocaust". Another Jewish historian, Norman G. Finkelstein, in his book "The Holocaust Industry" (Reflections on the Exploitation of Jewish Suffering), wrote that Jewish survivors of the Nazi holocaust received a minimum compensation from the tens of billions of dollars paid by Germany, while the rest, which was a large sum of money, was retained by the Jewish Zionist organization, which has nothing to do with the "holocaust". To extort money from Germany, Jews claimed that 6 million of their people died under Nazis, but they never proved this by indexing their official names from archived files, which is unacceptable as a fact. There is no doubt about the so-called Nazi holocaust being an industry to collect as much money as possible, which is unjust.

I am not denying that the Jews suffered or were murdered during the Nazi times, because they ruined Germany's industry and economy and installed a communist regime in Russia, which they tried installing in Germany and other European countries. For these reasons Adolf Hitler began a war against the Soviet Judeo-Bolsheviks and their collaborators, and I reject the Jewish accusation that there was a holocaust against them in Romania. On the contrary, the Judeo-communists committed a red holocaust against the Romanian nation, peace, and humanity.

From sources published by representatives of Jewish organizations in Romania after WWII, it was clearly evidenced that around 40,000 Jews died in Romania during the Fascist-Militaristic regime of Marshall Antonescu and the Iron Guard. Now, to extort money from Romania, the Zionist elite circle added another zero to the 40,000 dead Jews and pretend that 400,000 Jews died. This is unacceptable as a true fact! A great priest of the "holocaust", Elie Wiesel, who hunts the memoirs of Romanian heroes and martyrs, to strengthen the false accusations of the Zionist supremacy, stated that "Romania killed, killed, killed". That is insane! Historians and ordinary people fear verifying this or talking about this subject because they are afraid of being accused by Jews of anti-Semitism, or being punished by laws introduced by Jews in many countries, including Romania.

However, don't believe for a second that I am an anti-Semite because I say these things. No, no, I am not an anti-Semite, but I'm against certain Jews and anti-Zionists because they founded socialism and communism and are responsible for the abuse, terrors, crimes, genocides, and the red holocaust committed by the Judeo-Zionist-communist regime in my native country, Romania, against the Romanian nation, peace, and humanity. The Jews are also responsible for the holocaust committed against Palestinians. Anti-Semites are Jews through the fact that they erased Palestine from the face of the Earth and have a fanatical and criminal hate against over 300 million Arab-Semites, who are the ones most entitled to represent the Semitic race, not the Jews, who the majority of which have descended from Khazaria, a semi-nomadic Turkic people who converted to Judaism. Perhaps you don't agree with me, but this is historical truth, and Jews can't hide this reality or rewrite their own international Jewish version of history just as they please.

As a leader of a great nation, a superpower country like Russia, will you be kind enough to introduce a resolution at the United Nations to stop Jews from accusing people of "anti-Semitism", or "hate-crimes", or "racist-hate" for telling the truth about the international Jewish conspiracy? Can you make this effort, or are you afraid?! Jews are a very small part of the Semitic race, but people are against them for all the immoral and unethical acts they committed against humanity, not because they belong to a Semitic race. It is good to keep in mind that the majority of the Semitic-race doesn't even recognize Israel or Jewish-Zionist organizations, so Jews cannot have a monopoly over Semitic people.

I'm sure you know that, international communism and socialism was not created by Russians, but founded by Jews to enslave and dominate the world. The proof is evidenced by the fact that the most prominent leaders of the communist and socialist ideology, such as: Adam Weissaupt – the founder of the Order of Illuminati, a secret society of the New World Order, Friedrich Engeles and Karl Marx (Kissel Mordekay)- the chief theoreticians of international Communism, The homosexual Vladimir Ilyich Lenin (Israel Blank) - the founder of Judeo-Bolshevism and the first head of the Russian Soviet Socialist Republic from 1917 to 1924, Leon Trotsky (Lev Davidovich Bronstein) - the founder of the Red Army, I.V. Stalin (Dzhugashvili)- the Chief Architect of Soviet totalitarianism from 1929 to 1953, Felix Edmundovich Dzerzhinsky - the founder of the Bolshevik secret police, the Cheka, Lavrentiy Pavlovich Beria- the Chief of the Soviet security and secret police apparatus under Stalin, the NKVD, Ivan Aleksandrovich Serov - the head of the Soviet secret police, the KGB and many others, were all true Jews or got married to Jewish women.

Lenin and his clique installed communism in power in Russia with the financial support from rich Jews from the West, such as Jacob Schiff, the Wartburg brothers, and other Jewish bankers. Also, voluntarily thousands of far-leftist Jews from New York (Manhattan, West Side) went to Moscow to help Lenin, both morally and physically, to install communism to power and experiment it. In the name of communism and socialism, these Jewish-communists committed the most sinister and bloody acts of terror, crimes, genocide, and red-holocaust against the Russian nation and other nations. And I don't understand why you keep these anti-humane facts a secret and glorify the Soviet system? Are you perhaps a Jew by origin or a Zionist lover? If not, how do you explain that the majority of Russia's population had a rough life under the Soviet Union and continue to have one now, and during the time of your presidency more billionaires appeared in Moscow, overnight, than there are in New York, (the majority of which are the same Jews who control and ran the communist dictatorship)?! Until 1990, all the possessions and wealth that these billionaires in Russia had was simply the red identification of communism or the KGB, and now through a mafia-style business they rub their hands with billions of American dollars, not rubles. Why do you tolerate this corruption, is it because they accept you as their boss? I saw that during the inauguration parade for the new successor, at the Kremlin, Dmitry Medvedev, which you participated in, there appeared a communist red flag with USSR symbols. What did you want to demonstrate through this, that you and Mr. Medvedev are one step away from the restoring the Soviet Union? If so, then stop pretending to be a true nationalist or a democrat because you are not. A true nationalist or a democrat would never eulogize the

communist evil empire which is full of sad memories. We who watched this Stalinist-style military parade from a distance smiled sardonically for the naiveté and stupidity of those who organized this funeral procession for the former USSR. It is very sad that 20 years after the collapse of the Soviet Union, Soviet symbols with hammer and sickle are still used in government, parliament, and presidential buildings in Moscow and other Russian cities. And why do you keep the body of Vladimir Ilici Lenin in the Mausoleum placed in the Red Square in Moscow, because he was a suppressor of the “bourgeois-landowners” regime, or because he was a homosexual?

Mr. Levy mentions in his article that: “Officials at the security archives, which are now mostly controlled by the F.S.B. and the Interior Ministry, typically reject requests for access by citing a need to protect state secrets and personal privacy.... The director of the F.S.B. archives in Moscow, Vasily Khristoforov, has said all records related to “ways and methods of operational investigative activity” will never be declassified”. One of the reasons that the FSB kept these documents a secret is because many officers and KGB informers are active in FSB and don’t want to share with people that they used the similar methods and tactics used during the Soviet Union. Another reason that the FSB didn’t allow access to the Secret Service archives is because they didn’t want historians or the public to find out from Nazi archives, taken by the Red Army from Auschwitz and other Nazi concentration camps, that there isn’t sufficient evidence proving that Nazis killed 6 million Jews during WWII. Hollywood movies about the Nazi holocaust against Jews made after WWII are not historical authentic facts, but sources of Zionist propaganda.

Also, Mr. Levy states that: “Archives from Stalin’s secret police have become a flash point because of the rise of a movement that has sought to idolize Stalin as a leader who defeated Nazi Germany, spurred industrialization and made the Soviet Union a superpower.” This glorification of Stalin is ridiculous and absurd. And keep in mind that the Soviet Union would not resist and survive Nazi Germany and the Axis forces during WWII, if the United States did not freely supply a tremendous amount of money, food, clothing, high technology, arms and ammunitions. And this can be proved by authentic documents in American national archives. Without the financial, material, and moral help of the United States and England, the Soviet Union would have been defeated by Nazi Germany and the Axis Powers and never would have become a world superpower. But people with communist mentality and without credibility like Gennady Zyuganov, Garry Kasparov (Weinstein), and others all talk nonsense about Stalin’s “victory” and the great “patriotic” war against Nazi Germany and the Axis. Where is the justification for this great heroism of Stalin, in the fact that Russian soldiers who abandoned the fight against the Nazi Army were shot in the head by Soviet Judeo-Bolshevik political commissars? So those people who idolized Stalin for taking the lives of tens of millions of people while he said “No man, No problem” (Niet celovec, Niet problem) are irresponsible and hypocrites.

As a revisionist of history, I have news for you Mr. Putin. If the Romanian King, Mihai Hohenzollern (a secret and dangerous agent of the Zionist-communist conspiracy) wouldn’t have arrested Marshal Ion Antonescu – Commander in Chief of the Romanian Army and head of the Romanian State in August 1944, the Red Army which reached the Prut River would have retreated back to Moscow, instead of seeing Berlin. For these shameful acts of national betrayal committed by King Mihai Hohenzollern, the communist dictator, Stalin, decorated him with the highest communist medals “Pobeda”.

The truth is that without military interventions from the U.S. and Great Britain, Nazi Germany would never have surrendered and never would have been defeated. Many Russians that are brainwashed by communist theories sustain that Stalin and communists modernized Russia. Stalin and other communists knew only how to drink vodka and bark orders. The modernization of the Soviet Union after WWII was made possible by German, Romanian, Japanese, and other POWs, and by millions of people deported from their homes and forced into hard labor in the USSR gulag. Even the nuclear technology of the Soviet Union wasn't a scientific discovery by communists, but stolen from the U.S. by Jewish spies. But those times are now history, and the people who tasted liberty will never go back to that ordeal simply for the love of certain communist adepts with sick minds. To be fair, how can one compare the luxurious cities of the capitalist world like: New York, Honolulu, Paris, Tokyo, Bangkok, Hong Kong, Dubai, and Rio de Janeiro, to name just a few, to the poor socialist cities of the Soviet Union, which were in the dark with all the "light" of Ilici Lenin? As a matter of fact, the cities of the former Soviet Union with great value were the ones with buildings constructed during the Russian monarchy, not the ones built during socialist times. I can fairly say that Russia progressed greatly after the collapse of communism and developed famously illuminated buildings with high-end shops, supermarkets, hotels, restaurant, and disco-techs throughout its cities.

Referring to the activities of Russian history given in evidence by Vasily A. Khanevich, to discover the truth from the Soviet Security archives, in an article, Mr. Levy quotes Khanevich as stating: "Russia positions itself as a completely different democratic country with democratic values, but at the same time, it does not reject, it does not disassociate itself and does not condemn the regime that preceded it...On the contrary, it defends it...These are people with epaulets, and they have to carry out orders, but the orders are not always humane and sometimes they are criminal". Mr. Khanevich also said: "They need to think about whether it's the right thing to do to carry them out. Of course, they may lose their epaulets. But they will remain human beings, with their dignity intact." Similarly Mr. Levy wrote about "A prominent historian, Sergei A. Krasilnikov of Novosibirsk State University in Siberia, said officials routinely cited personal privacy and other regulations to block access. But it is a ruse, he said". Krasilnikov said "The order has been given to rehabilitate Russian and Soviet statehood in all epochs and in all times — for all the czars and general secretaries...This is why we have all these restrictions on access to the archives, because the archives allow us to show more profoundly the mechanisms of power, the mechanisms of decision-making, the consequences of these decisions, which were very often tragic for society." Even Gorbachev's paternal grandfather was sentenced to nine years in the gulag by Stalin for anti-Soviet activity. Yeltsin's father was also convicted of anti-Soviet agitation, and sentenced to hard labor in the gulag for three years. For these reasons, they hate communist tyranny and disassembled the Soviet Union.

Regarding a statement you made at a conference where study guides were presented, Mr. Levy quoted you as saying: "We do have bleak chapters in our history; just look at events starting from 1937... And we should not forget these moments in our past... But other countries have also known their bleak and terrible moments... In any event, we have never used nuclear weapons against civilians, and we have never dumped chemicals on thousands of kilometers of

land or dropped more bombs on a tiny country than were dropped during the entire Second World War..." It is true that the U.S. used atomic bombs to kill hundreds of thousands of innocent people in a few seconds, but during that time, your country, Mr. Putin, was allies with the U.S. and the United Kingdom, so is as guilty for this horrible anti-human nuclear attack. I understand that you try distracting attention from the Soviet Union for killing over 60 million innocent people, but you can't hide the truth forever Mr. Putin, and you should respect your words "not forget these moments in our past." as you stated. My ancestors are from Moldova, and I wish that my Moldovan and Romanian brothers, who endured the persecutions, starvations, uprisings, massacres, deportations, imprisonments, and assassinations by the Soviet Secret Police, get access to their files in the FSB archives and be compensated for their suffering and lose.

With this occasion, I would like to bring to your attention another critical and unresolved problem: -Moldovan territories from Ukraine and Romanian treasures in Moscow. Historically and geographically, Moldova and Romania was the land of the former Geto-Dacian Empire from Nistru to Tisa. From its founding in the 14th century, Moldova is bordered by the Dniester (Nistru) River to the East and the Danube (Dunarea) and Black Sea to the South, the Carpathian Mountains to the West, and the Cereus River to the North. The country's surface is 36,409 square miles (94,301sq km), which was established in 1412 A.D. under the rule of Alexander the Good (1400-1432). The inhabitants of this land are generally considered as belonging to the Thracian nations. An initially autonomous and independent state, it existed from the 14th century to 1812, when half of Moldova was occupied and annexed illegally by the Russian Empire. With the purpose of changing the Moldovan identity of Moldova, Russia gave it the name Bessarabia. This Moldovan territory was partially or integrally recovered, but the truth is that throughout history, Russia and later the Soviet Union both occupied Moldova illegally 13 times.

In 1924, the Soviet Union established beyond the Nistru River, in a region named Transnistria, an artificial republic and proclaimed it Moldova ASSR. Transnistria, with its mostly Moldovan and Romanian ethnic majority is not a part of Moldova. One of the reasons for the creation of the Moldovan ASSR, at that time, was to eventually incorporate half of Moldova (Bessarabia) to the Soviet Union. But Bessarabia remained in the components of Romania, its motherland country until 1940. In 1939, the Molotov-Ribbentrop Pact was signed, which anticipated that Bessarabia and Northern Bukovina would enter into the Soviet Union sphere of influence. After these illegal acts, Romania was forced to give up all of Bessarabia and the Northern Bukovina territory to the Soviet Union in June 1940. Central and Northern Bessarabia formed the center of the new Soviet Socialist Republic of Moldova, but part of the south, and Northern Bukovina, including the Herta region were annexed to the Ukrainian SSR during June 28 through August 7, 1940.

In June Of 1941, the Fuhrer Adolf Hitler broke this pact, and Axis forces invaded the Soviet Union in the course of WWII and defeated Soviet troops in the region. Romania, which joined Hitler's Axis, recovered Bessarabia and Northern Bukovina and liberated all Moldovan territories that were occupied by Moscow's Army and government since June of 1940. With the support of the U.S. and England, Soviet troops retook this territory from Romania in 1944 and reconstituted it again Moldova SSR, and invaded and occupied Romania from 1944 through 1957. When the Soviet Union broke down in 1991, Moldova SSR, which was formed in 1940 and re-established, again in 1944, became an independent country named the Republic of Moldova. But part of the south, now known as Budjak, Snake Island (surface area of 17 hectares) in the Black Sea, Herta region, and Northern Bukovina, were administrated illegally by the Ukrainian SSR and unlawfully forced to become a part of the independent Ukraine in August 24, 1991. Today, the Western part of Moldova is now part of Romania (42%); the Eastern part belongs to the Republic of Moldova (33%), while the Northern and Southeastern parts are territories illegally annexed by Ukraine (25%) since 1941, again in 1944, and later in 1991. Retaining these Moldovan territories as a component of Ukraine is an illegal act, a provocation against Moldova and Romania and a crime against the true history, peace, and human civilization. To correct this grave injustice, I ask that you, just like the governments in Moscow did during 1940 and 1944 when they occupied Moldovan territories by force, should similarly force Ukraine to give back

Northern Bukovina, Herta region, Southern Bessarabia, and Snake Island from the Black Sea to Romania. These territories are historically, geographically, and legally all part of Romania.

I am also asking that Russia gives Romania back its treasures. These treasures are a collection of valuable objects from the Romanian state, which were sent to Moscow during WWI after a protocol convention between the Russian and Romanian governments had agreed to store them at the Kremlin in Moscow until the war ended. The first shipment left Romania from Iasi on December 14-15, 1916 by means of 17 railway carriages which contained 1,738 cases full of gold coins and gold bars (approximately 97 tons of gold). Two cases of Queen Maria's jewelry, valued at the time at 7 million lei (Romanian money) in gold were added to this shipment. The second shipment left for Moscow in the summer of 1917 by means of 24 railway carriages which contained the most precious objects of the Romanian state, the archives of the Romanian Academy, many antique valuables, such as 3,500-year-old golden treasures, and other ancient Dacian jewels, thousands of paintings, precious religious objects, and other valuable objects. The bank value of these 21 railway carriages, with its 1,661 case was estimated at approximately 7.5 billion lei at the time.

These Romanian treasures reached Moscow intact and were deposited at the Kremlin. During the time of the Bolshevik revolution in 1917, Lenin confiscated the Romanian treasure and promised to return it the moment that Romania would be liberated from the "bourgeois-landowners" regime. In a telegram from 1918 addressed to Vladimir Alexandrovich Antonov-Ovseenko— commissar of People's Commissariat for Military Affairs, Lenin transmitted: "The rich values of the Romanian government must be kept with great care to be returned in good condition to Romania after the collapse of Romanian counterrevolutionaries". So if in 1918, Lenin was in possession of intact Romanian treasures, nobody can say that these treasures were split among Moscow's monarchy and the White Army, as it was erroneously circulated by some bizarre speculation.

The Romanian government made many claims to retrieve these treasures, which represents a great historic value of civilization, but were only returned a small part on two separate occasions. The first delivery took place in 1935, which consisted of documents from the archives, valuable maps, and property titles. The second delivery took place in 1956 and contained the Treasure of Petroasa, 33kg of gold, 690kg of silver, engravings and artwork, which also included 120 paintings by the famous Romanian artist Nicolae Grigorescu, books and antique miniatures, and jewelry. The Soviet Union's government refused to return the entire treasure, including the 91 tons of gold coins and the 2.4 tons of gold bars. On the contrary, after WWII, a third shipment of Romanian treasures was sent to Russia, however it was forcefully taken by Russia and contained 200,000 files from the archive of the Romanian state, including the archives from Marshal Ion Antonescu's office. During the thirteen years of Soviet occupation of Romania (1944-1957), under the pretext of War damages, Russia took a fourth Romanian treasure load, which contained petrol, wood, crops, livestock, and other natural resources. The Kremlin demanded \$300 million as compensation for the war, which was equivalent to 274 tons of gold. This was paid in full, but Russia continued taking natural resources from Romania, valued at over \$2 billion, which is not only horrendous, but a condemnable crime. In fact,

Moscow's government, spanning from the eras of the Russian monarchy, Soviet Union, and finally democratic times, should pay thousands of tons of gold as compensation to Romania, for illegally invading and occupying Moldova and Romania on 13 separate occasions since 1812.

On June 3, 2004 a mixed Romanian-Russian commission was founded to examine and recover Romanian Treasures stored in Moscow during WWI. The Romanian side of this commission is lead by the historian, Ioan Scurtu, while the Russian side is lead by the academician Alexandr Oganivici Ciubarian, but they cannot solve this problem because you, just like your predecessors from the Kremlin since 1917, refuse to return these treasures. Why? Are you a thief Mr. Putin and not a decent and civilized man with a law degree and a doctorate in economy?! Only thieves steal and refuse to give back what they stole. Why is it that even after 90 years Russia doesn't want to understand that Romanian treasures stored in Moscow since WWI, for safety reasons, does not belong to Russia, and should be returned to Romania? Russia cannot pride itself with foreign treasures which don't legally, culturally, and historically belong to it. This sabotage on Russia's part is shameful and ridiculous! These manifestations lack respect, reciprocity and dignity, and cannot improve relations between Romania and Russia or prove that Russia takes part of the civilized world. On the contrary, it irritates the Romanian and Moldovan wounds, which are still raw, that were provoked by Russian Tsars, the Soviet Union, and currently the Russian Federation. So think positively Mr. Putin, not only negatively, because other people have the right to life on Earth as well, not only the so-called World superpowers that serve the Zionist supremacy elite and try to dominate people. I hope that you understand the situation and will be honest enough to open access to Soviet Secret Police files from FSB archives, force Ukraine to return Southern and Northern Moldovan territories, and Snake Island to Romania, and return all of Romania's treasures from Moscow.
